# **Terms of Service**

### 1. Acceptance of the Terms

By accessing or using velithon.com or any prototype feature, you acknowledge that you have read, understood and agree to be bound by these Terms, our Privacy Policy and any additional guidelines we may post. If you do not agree, you must not access the Services.

# 2. Eligibility

You must be at least eighteen (18) years old and have the legal capacity to create a binding contract. You warrant that any registration information you provide is accurate and complete.

### 3. Licence Grant and Restrictions

Velithon grants you a limited, revocable, non-exclusive, non-transferable licence to use the Services for personal or internal business purposes in accordance with these Terms. You may not:

- circumvent technical or rate-limit safeguards;
